

## **ARTICLES OF INCORPORATION**

of

**SUNCOAST MEDICAL SCREENING SERVICES, INC.**

### **ARTICLE I - Name**

**EFFECTIVE DATE**  
12-23-04

The name of the corporation shall be:

**SUNCOAST MEDICAL SCREENING SERVICES, INC.**

### **ARTICLE II - Duration**

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

### **ARTICLE III - Purpose**


