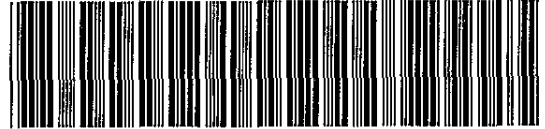

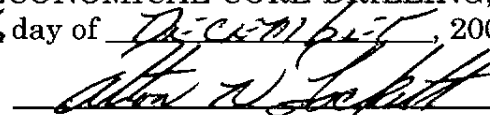
## ARTICLE IX

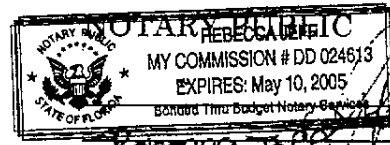
