The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is Cloverleaf Trails, Inc.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: DURATION

The duration of the corporation is perpetual.

ARTICLE IV: PURPOSE

- i. To purchase, lease, or otherwise acquire, sell, sublease or otherwise dispose of properties of every kind and nature, to operate a business in or expand any properties acquired, to manage businesses located on properties owned or not owned by the Corporation, and generally to engage in the business of dealing in investment properties.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of shares of capital stock, bonds, securities, or other evidences of indebtedness created by any person, firm or corporation, and while the owner of such stock, exercise all of the rights, powers, and privileges of ownership, including the right to vote the stock.
- 5. To purchase the assets of any other person, firm, or corporation and engage in the same or other character of business.
- 6. To enter into, make, and perform contracts for any lawful purpose pertaining to the business of the Corporation without limit as to amount, with any person, firm, syndicate, association, corporation, or governmental entity, domestic or foreign.

To further engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business; and engage in and transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
