

ARTICLES OF INCORPORATION

OF

MECKLENBERG DELIVERY SERVICE, INC.

Of OEC30 MILED The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: MECKLENBERG DELIVERY SERVICE, INC.

ARTICLE II: PRINCIPAL OFFICE
