The undersigned, acting as incorporator of RIVERO & ASSOCIATES CPAs, P.A., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND PRINCIPAL PLACE OF BUSINESS

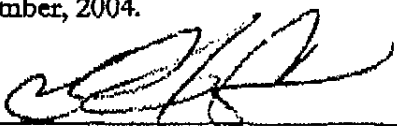
