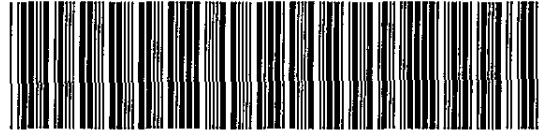

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

**ARTICLE I. NAME AND ADDRESS**

The name of the corporation shall be Sunshine Youth Management, Inc. (the "Corporation"). The address of the principal office of the Corporation shall be 4004 North Riverside Drive, Tampa, Florida, 33603, and the mailing address shall be the same.

**ARTICLE II. NATURE OF BUSINESS**

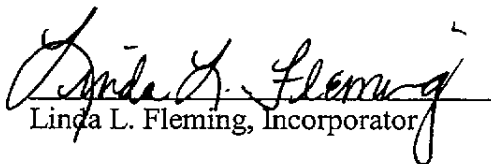
