





 company registered in the Commercial Register of the Curacao Chamber of Commerce &
 Industry and continuing as a company under the laws of Barbados under the name. Alphatur
 Inc.
- After due enquiry and to the best of my knowledge, information and belief and after reading the legal opinion of the law firm Baaten, Alexander, Berends of Gaitoweg 2, Curaeao, I am of the opinion:
 - (i) That the laws of Curacao permit companies to discontinue as such in Curacao and to continue as companies under the laws of another jurisdiction.
 - (ii) I have examined the copy of the extract of Book 2 of the Civil Code of Caracao and am satisfied that Articles 300 306 of the said Act permits Alphatur N.V. (the "Company") to discontinue in Curacao and to continue as a company under the laws of another jurisdiction, provided that the laws of that jurisdiction permit such a continuation.
