I, **Robert C. Worme, Attorney-at-Law of Carter's Complex, Wilkey, St. Michael, Barbados, MAKE OATH AND SAY as follows:**

1. I am an Attorney-at-Law duly admitted to practice law in Barbados only and make this Affidavit in respect of **Alphatur N.V.** a company that is in the course of discontinuing as a company registered in the Commercial Register of the Curacao Chamber of Commerce & Industry and continuing as a company under the laws of Barbados under the name **Alphatur Inc.**
2. After due enquiry and to the best of my knowledge, information and belief and after reading the legal opinion of the law firm Batten, Alexander, Berends of Gaitoweg 2, Curacao, I am of the opinion:
 - (i) That the laws of Curacao permit companies to discontinue as such in Curacao and to continue as companies under the laws of another jurisdiction.
 - (ii) I have examined the copy of the extract of **Book 2 of the Civil Code of Curacao** and am satisfied that **Articles 300 - 306** of the said Act permits **Alphatur N.V.** (the "Company") to discontinue in Curacao and to continue as a company under the laws of another jurisdiction, provided that the laws of that jurisdiction permit such a continuation.
3. The interpretation of the laws of the Curacao expressed herein is applied from the point of view of the laws of Barbados.
4. I make this Affidavit in support of the application by **Alphatur N.V.** for continuance as a body corporate in Barbados.
5. This application for continuance is in compliance with the laws of Barbados.

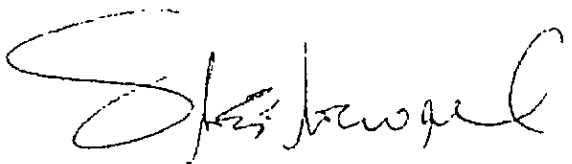
