

- 4. The foregoing amendments to the Articles of Incorporation have been duly approved by the board of directors.
- 5. The foregoing amendments to the Articles of Incorporation have been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding common shares of the corporation is 9,500. The number of shares voting in favor of the amendment equaled or exceeded the vote required.
