# ARTICLES OF INCORPORATION

The undersigned do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

### ARTICLE I - NAME AND ADDRESS

The name of this corporation is JACY HAIR SALON CORP. The address is 22032 S.W. 122<sup>nd</sup> Avenue, Miami, Florida 33170.

# ARTICLE II - PURPOSE

This corporation is organized for the purpose of:

- Transacting any and all lawful business for which a corporation may be incorporated under Florida Statutes.
- Transacting a full service hair salon and barber shop business catering to men, women, and children.

### ARTICLE III - CAPITAL STOCK

This corporation is authorized to issue 100 shares of no par value common stock, which shall be designated as "Common Shares". All of said stock shall be payable in cash or property (real or personal) at just valuation to be fixed by the Board of Directors.

### ARTICLE IV - VOTING
