10. Officers. The initial officers of the corporation shall be: Ron Edsall as President, and Treasurer, and Sharon Edsall as Secretary.

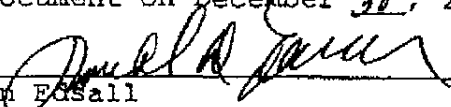
