ARTICLES OF INCORPORATION

OF

Sirius Ventures, Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a hatural person, hereby acts as an incorporator in adopting and filing the following articles by incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Sirius Ventures, Inc.

ARTICLE II

The existence of the Corporation shall begin on January 3, 2005.
