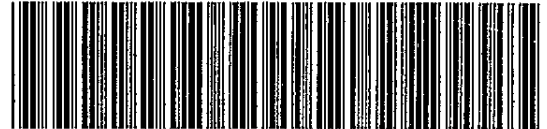

ARTICLES OF INCORPORATION.
OF

ARTICLE I. NAME

The name of this corporation is BRUMIL ENTERPRISES, INC.

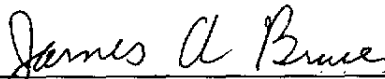
