

#### ARTICLES OF INCORPORATION

OF

#### ARTICLE I. NAME.

The name of this Corporation is VINCI INVESTMENTS, INC.

#### ARTICLE II. DURATION.

This Corporation shall have perpetual existence.

#### ARTICLE III. PURPOSE.

This Corporation is organized to transact and carry on any activity or business permitted under the laws of the United States of America and the State of Florida.

#### ARTICLE IV. CAPITAL STOCK.
