The undersigned incorporator to these Articles of Incorporation, <u>IS</u> a natural person competent to contract in the State of Florida, hereby presents these Articles of Incorporation for the formation of a corporation under the laws of the State of Florida.

ARTICLE 1. NAME

The name of the corporation is: SKY HI RECORDS, INC.

The general nature of the business to be transacted by this corporation is:

- a. To engage in every day activity or business permitted under the laws of the United States and the State of Florida.
- b. To develop and write software programs of all types for use on and off the internet for businesses and individuals. To provide these software development services as a contracted company of as a turn-key software solution on a for-profit basis.
- c. - d.
