

# ARTICLES OF INCORPORTATION OF QUE CUSTOM HOMES & DESIGN,INC

# ARTICLE I – NAME

The name of this corporation is QUE CUSTOM HOMES & DESIGN, INC.

# ARTICLE II - DURATION

This corporation shall exist perpetually

# **ARTICLE III- PURPOSE**

This corporation is organized for the general purpose of the following:

- 1.) To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with products, goods, wares, merchandise, real and personal property and services of every kind, class and description.
- 2.) To organize, equip and manage a contracting business for construction of dwellings.
- 3.) It is intended that this corporation is organized for and may conduct and transact any or all lawful business authorized and not prohibited by chapter 607, Florida Statutes, as the same may be from time to time amended. Provided, however, and notwithstanding the generality of the foregoing, this corporation is not to conduct a banking, safe deposit, trust, insurance, surety, express, building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition business.

# ARTICLE IV- CAPITAL STOCK

This corporation is authorized to issue 1000 shares of common stock having a par value of \$1.00. There shall be only one class of stock.

#### ARTICLE- V

Every shareholder, upon the sale of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof(as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.




