ARTICLES OF INCORPORATION
OF
DWH-COMMUNITY SOLUTIONS, INC.

The undersigned natural person, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the Corporation is DWH-Community Solutions, Inc.

ARTICLE II

Principal Office

The street address and mailing address of the principal office of the Corporation is 38 East Park Avenue, St. Augustine, Florida 32084.

ARTICLE III

Nature of Business

The general nature of the business to be transacted by this Corporation is to engage in any activity or business permitted under the laws of the United States or this State.

ARTICLE IV

Shares of Stock

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock at par value of \$1.00 per share.


ARTICLE IX
