WE, THE UNDERSIGNED, hereby associate ourselves together for the purpose of ALLEGEE, FLORIDA becoming a corporation under the laws of the state of Florida providing for the formation, liability, rights, privileges and immunities of corporations for profit.

ARTICLES I, NAME
