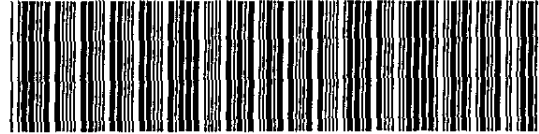

## ARTICLE XI – SMALL BUSINESS CORPORATION & SECTION 44 STOCK




