ARTICLES OF INCORPORATION OF SHEILA RAULERSON, P.A.

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a Florida business corporation.

ARTICLE I Name

The name of the Corporation shall be SHEILA RAULERSON, P.A.

ARTICLE II Purpose

The Corporation shall have the power to engage in every aspect of the general business of real estate marketing. The professional services involved in the Corporation's general business may only be rendered through its members, officers, employees, and agents who are duly licensed or otherwise legally authorized to render such professional services within this state.

ARTICLE III Effective Date
