ARTICLE I  
Name

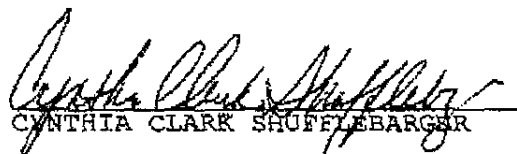
