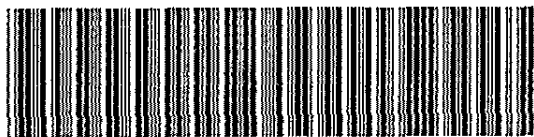



ARTICLE I

The name of this corporation is **OLIMANDA LEASING CORP.** and its principal office is located at:

DURATION

The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.



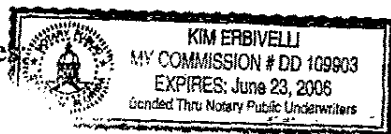


