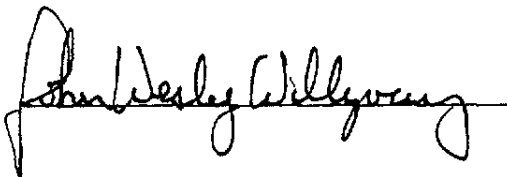

ARTICLE I. NAME

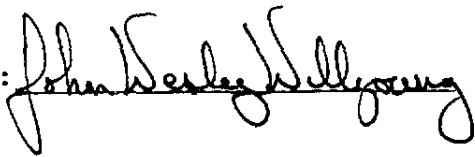

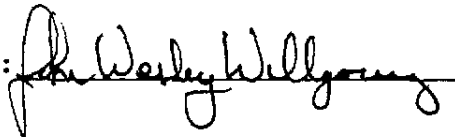
