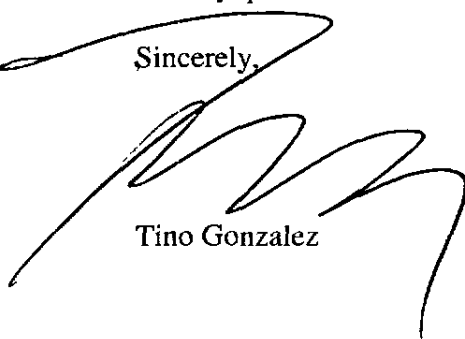

**ARTICLE I - CORPORATE NAME**

The name of this corporation is GREEN LEAF LAWN MAINTENANCE, INC., whose principal office and mailing address is 5400 Sand Lake Drive, Melbourne, Florida 32934.

**ARTICLE X - AMENDMENT**

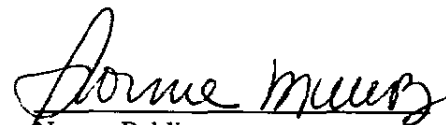

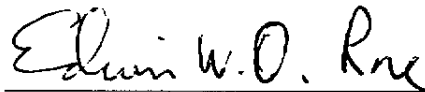
