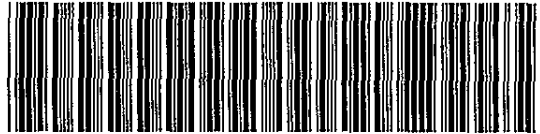

The existence of this corporation shall commence on the date of subscription and acknowledgement of these Articles, and shall be perpetual.



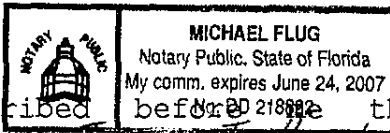


