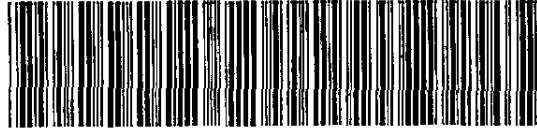

**ARTICLE I - CORPORATE NAME**

**ARTICLE X - AMENDMENT**

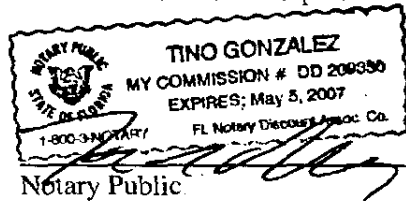
