**ARTICLES OF INCORPORATION
OF
STONETREE PROPERTIES, INC.**

Article I

Name. The name of this Corporation is Stonetree Properties, Inc.

Article II

Principal Office. The principal place of business and mailing address of this corporation shall be 550 Northwest 58th Street, Gainesville, Florida 32607.

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of filing these articles.

Article IV

Purpose.
