**ARTICLE XI – Amendment**



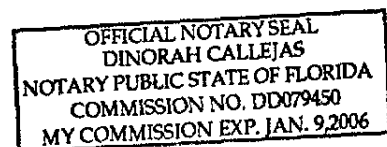
