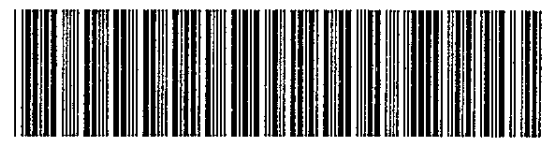

1. The name of the corporations is:



3. This Amendment was adopted by all of the directors and shareholders of this corporation on January 24, 2005.


