THE UNDERSIGNED, being of legal age and a natural person does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

FIRST: The name of this corporation shall be:

Insite Consulting, Inc.

SECOND: This corporation shall commence its existence on the date of the filing of these Articles of Incorporation with the Florida Department of State and this corporation shall exist perpetually thereafter unless sooner dissolved according to law.
