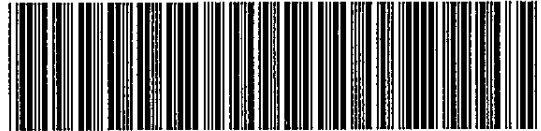

Article VI - Initial Board of Directors



Article VII - Amendment






