## X. AMENDMENTS

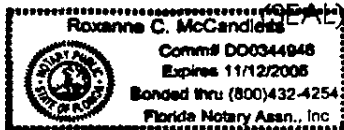


