# **DENICE JORDAN, P.A.**

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of forming a professional service corporation for profit, in accordance with the laws of the State of Florida, Chapter 621, Florida Statutes.

<u>FIRST:</u> The name of this professional service corporation shall be (hereinafter called the "Corporation") DENICE JORDAN, P.A.

**SECOND:** The period of duration of the Corporation is perpetual.

<u>THIRD:</u> The purpose for which the Corporation is organized, which shall include the authority of the Corporation to engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act, which includes but is not limited to:

Buying and selling real estate and any other transactions or services as needed, and to perform all activities related thereto without limitation, to invest in real estate, mortgages, or any other type of investments, to own real and personal property necessary for the rendering of the above professional services, and in general, to have and exercise all powers conferred by the laws of Florida upon personal service corporations, and to do any and all things here and above set forth to the same extent as a natural might or could do.

# **FOURTH:** Authorized Shares

EIGHTH: The Corporation shall, to the fullest extent permitted by the provisions of Florida Statutes, Chapter 621, and the Florida Business Corporation Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, vote of shareholders or disinterested directors, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.
