The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE 1

NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is FINANCIAL FACT SERVICES, INC.

Section 1.2 Address of Principal Office. The address of the principal office of the corporation is 240 Serenata Dr. N. # 833, Ponte Vedra, Florida 32082.

ARTICLE 2

DURATION

Section 2.1 Duration. This corporation shall exist perpetually.
