ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: Article I "Name, Address and Registered Agent" of the Articles of Incorporation of the Corporation is amended to read as follows:

ARTICLE I NAME, ADDRESS AND REGISTERED AGENT
