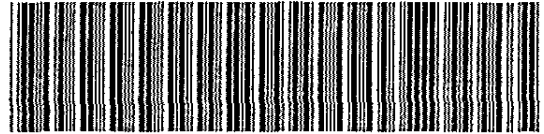



ARTICLES OF INCORPORATION
OF
DEZIRING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, and in compliance with Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I: CORPORATE NAME

The name of this corporation shall be **DEZIRING, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is 648 15th Street N.W., Naples, Florida 34120.

ARTICLE III: PURPOSE

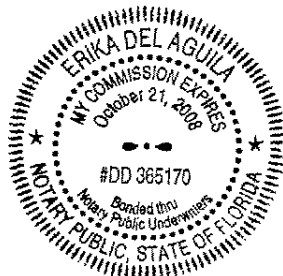
