ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

The name of this Corporation is DAZA & MARULANDA TRANSPORTATION, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on January 7, 2005.


