ARTICLES OF INCORPORATION

OF

R. E. LIVINGSTON, INC.

The undersigned incorporator, for the purpose of forming a corporation in the state of Florida hereby adopts the following Articles of Incorporation.

Article I

Name and Duration

The name of this corporation is R. E. Livingston, Inc. The duration of the corporation is perpetual. The effective date upon which this corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

Article II

Principal Office

The address of the principal office and mailing address of the corporation in the State of Florida is 10739 Deerwood Park Boulevard, Suite 200, Jacksonville, FL 32256.

Article III

Capital Stock

The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is one hundred (100) shares having no par value.

Article IV

Registered Office and Agent

The street address of the registered office of this corporation is 10739 Deerwood Park Boulevard, Suite 200, Jacksonville, FL 32256 and the name of the registered agent of this corporation at that address is Robert E. Livingston.

Article V

Directors

1. This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one (1). The manner of selection of directors shall be as provided in the bylaws.

The power to adopt, amend or repeal bylaws for the management of this corporation shall be vested in the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to the amendment or repeal by the Board of Directors.

Incorporator






