ARTICLE I
NAME

The general nature of the business and the objects and purposes to be transacted and carried on by this Corporation shall be:

- (a) This Corporation is organized with the purpose to engage in the Installation of Hurricane Shutters and all other lawful activities permitted under the laws of the State of Florida and the United States of America.


