

Pursuant to the provisions of Section §607.1006, Florida Statutes by corporate resolution and unanimous agreement of the shareholders and directors, this corporation, AIR ON TIME, INC. adopts the following Articles of Amendment to its Articles of Incorporation:

## FIRST:

Amendment(s) adopted:

A) ARTICLE IV. shall be deleted in its entirety and replaced with the following:

# "ARTICLE IV. CAPITAL STOCK

The corporation shall be capitalized as follows: The total number of shares of common capital stock authorized shall be <u>one hundred (100)</u> shares of common stock having a revised par value of \$306.12 (three hundred and six dollars and 12/100 cents) per share.

All or any part of said capital stock may be paid for in cash, in property (excepting stock and securities in labor or services or any combination thereof) at a fair valuation to be fixed by the incorporator at a meeting called for such purpose. All stock when issued and fully paid shall be non-assessable. These shares shall be designated "common shares".

The Board of Directors is authorized to issue "Section 1244 Stock" as defined in Section 1244 of the Internal Revenue Code.

Any shareholder and any representative of a deceased or incompetent shareholder of AIR ON TIME, INC. may sell or transfer his/her shares in such corporation.

Currently, fifty-one (51) shares of said common stock will be issued to MARK W. BRADLEY, Co-Director and forty nine (49) shares of said common stock will be issued to MR. REIN A. JAAKSON, Co-Director, with the corporation having the ability to issue new shares of common stock for future expansion as empowered by these Articles and by Florida Law.

All corporate shares held by MARK W. BRADLEY and REIN A. JAAKSON, the Co-Directors of AIR ON TIME, INC., shall be held as Tenants-In-Common, and **not** as Joint Tenants with Rights of Survivorship."



B) ARTICLE V. REGISTERED AGENT shall be deleted in its entirety and replaced with the following:

"ARTICLE V. REGISTERED AGENT

The name of the registered agent of this corporation at that address is:

C) ARTICLE VII. INITIAL OFFICER(S) AND/OR DIRECTOR(S) shall be deleted in its entirety and replaced with the following:

# "ARTICLE VIII. BOARD OF DIRECTORS

Although there was one initial director/president of the corporation, AIR ON TIME, INC., MR. MARK W. BRADLEY, subsequently, via corporate resolution, AIR ON TIME, INC. and MR. MARK W. BRADLEY transferred 49 shares in the corporation, to REIN A. JAAKSON, who shall now serve as the Co-Director of AIR ON TIME, INC.

The number of Directors may be increased (or, at a later date, should there be more than Director, diminished) from time to time by By-Laws adopted by the stockholders, but shall never be less than one (1). The names and address of the member of the current Board of Directors are:

And

The corporation shall indemnify any and all persons who may serve or who have served at any time as Directors or Officers, or who at the request of the Board of Directors of the corporation may serve or at any time have served as Directors or Officers of another corporation in which the corporation at such time owned or may own shares of stock or

of which it was or may be a creditor, and their respective heirs, administrators, successors, and assigns, against any and all expenses, including amounts paid upon judgments, fines, counsel fees, and amounts paid in settlement (before or after suit is commenced), actually and necessarily incurred by such person in connection with the defense or settlement of any claim, action, suit, or proceeding in which they, or any of them, are made parties, or a party, or which may be asserted against them or any of them, by reason of being or having been Directors or Officers or a Director or Officer of the corporation, or of such other corporation, except in relation to matters as to which any such Director or Officer or former Director or Officer or person shall be adjudged in any action, suit, or proceeding to be liable for gross negligence or intentional misconduct in the performance of his/her duty. Such indemnification shall be in addition to any other rights to which those indemnified may be entitled under any law, By-Laws which may be drafted contemporaneous with these Articles of Incorporation or at a later date, agreement, vote of stockholders, or otherwise."
