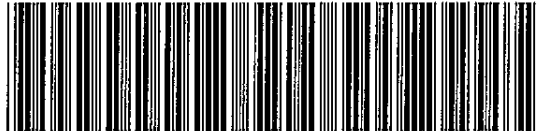

of




