#### ARTICLES OF INCORPORATION

<u>OF</u>

#### COOK PLAZA, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE

The name of the Corporation is COOK PLAZA, INC.

## ARTICLE TWO

The duration of the Corporation is perpetual.
