## **ARTICLES OF INCORPORATION**

**OF**

### **SOUTH COM GROUP, INC.**

The undersigned, acting as an incorporator of a corporation Under Chapter 607, Florida Statutes, the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

#### **ARTICLE I**

##### **Name**
