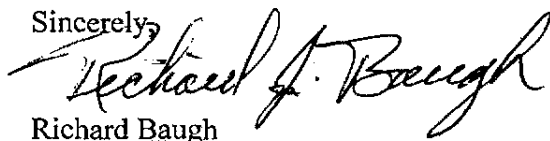

**ARTICLES OF INCORPORATION**

**OF**

THIS IS TO CERTIFY that the undersigned, acting as an incorporator under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I**  
**NAME**

The name of the corporation shall be: Richard Baugh, P. A.

**ARTICLE II**  
**ADDRESS**

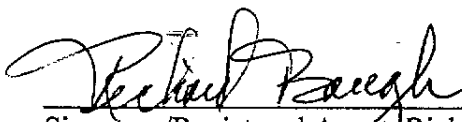
