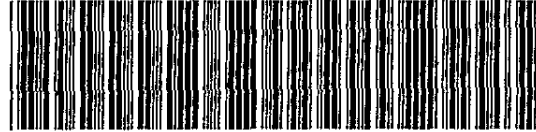

**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME**

The name of this corporation is DANIEL J. HENZLER, P.A.

**ARTICLE II - PURPOSE AND NATURE OF BUSINESS**

The purpose of the Corporation and the nature of its business are as follows:

1. To engage in the practice of a real estate broker/salesperson as a professional service corporation and to provide services incident thereto.
2. To own property, enter into contracts and carry on any activity necessary or incidental to the accomplishment or furtherance of the purpose of this Corporation.
3. The services of this Corporation which consist of the practice of a real estate broker/salesperson shall be carried out only through officers, employees and agents who are in good standing with the Florida Department of Business and Professional Regulation and licensed in Florida to render the service of a real estate broker/salesperson.
4. To do everything necessary, proper or convenient for the accomplishment of any of the purposes herein set forth, and to do every other act incidental thereto which is not forbidden by the laws of the State of Florida, by the Professional Standards of the Florida Real Estate Commission or by the provisions of these Articles of Incorporation.

### **ARTICLE III – CAPITAL STOCK**

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is 7,500.00 shares having a par value of \$1.0 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than an individual who is duly licensed to practice as a real estate broker/sales person in the State of Florida and is in good standing with the Florida Department of Business and Professional Regulation.

### **ARTICLE IV - DURATION**

The Corporation shall have perpetual existence.

### **ARTICLE V – ADDRESS AND AGENT**

The street address of the principal and initial registered office of the Corporation is 791 West Lumsden Road, Brandon, Florida 33511, and the name of its initial registered agent is Michael J. McDermott. The Board of Directors may from time to time move the office to any other address in the State of Florida and change the registered agent.

### **ARTICLE VI - DIRECTORS**

The Corporation shall be managed by a Board of Directors of at least one (1) Director. No person shall serve as a Director of the Corporation unless the person is duly licensed to practice as a real estate broker/sales person and is in good standing with the Florida Department of Business and Professional Regulation. The Directors

shall be elected by the shareholders of the Corporation. The name and street address of each person who is to serve as a member of the initial Board of Directors is as follows:

No shareholder may sell or transfer his shares in the Corporation except to another individual who is eligible to be a shareholder of the Corporation under Florida law.


**ARTICLE IX - DISQUALIFICATION**

If any officer, shareholder, agent or employee of the Corporation who has been rendering professional service to the public for the Corporation becomes legally disqualified to render such professional services within Florida or accepts employment that places restrictions or limitations upon his or her continued rendering of such professional services, then the Corporation shall require him or her to comply with the Florida Professional Service Corporation Act by severing all employment with and financial interests in the Corporation.

ARTICLE X - AMENDMENT

These Articles of Incorporation may be amended in the manner provided by law.


