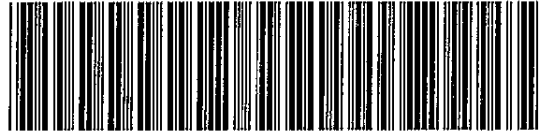

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I – NAME

The name of the Corporation is CRAGCO, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence, commencing on the date these Articles of Incorporation are filed with the Department of State, State of Florida.
