# ARTICLES OF INCORPORATION OF R & S MAINTENANCE SERVICES OF NORTH FLORIDA, INC.

OF THE SOLVES The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, hereby form a corporation under the laws of the State of Florida, effective January 1, 2005.

#### ARTICLE I

The name of this corporation is R & S MAINTENANCE SERVICES OF NORTH FLORIDA, INC.

# **ARTICLE II**

The general nature of this business to be transacted by this corporation is general residential cleaning and maintenance services and related services.

To manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise to dispose of, and to invest in and deal in and with, goods, wares, merchandise, real and personal property and services of every class, kind and description, now or hereafter permitted by law.
- 4. To conduct business in, have one or more offices in and to buy, hold, mortgage, sell, convey, lease, or otherwise dispose or real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and in all other states and countries.
- 5. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and to execute such mortgages, transfers of corporate indebtedness as required.
- 6. To purchase the corporation assets of any other corporation and engage in the same or other character of business.
- 7.
