ARTICLES I: NAME OF THE CORPORATION

The name of the corporation H&L UNITED DISTRIBUTORS INC., here in after referred to as the "Corporation".

ARTICLES II: PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III: DURATION OF THE CORPORATION
