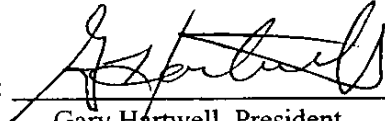

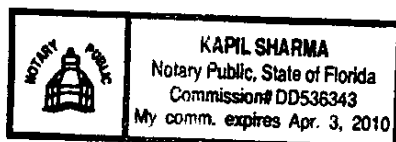
1. Gary Hartwell is the President of GARY HARTWELL CONSTRUCTION, INC., a Florida corporation, (hereinafter "Corporation").

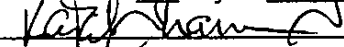
