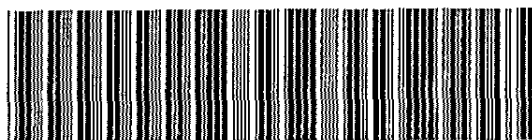

Name**

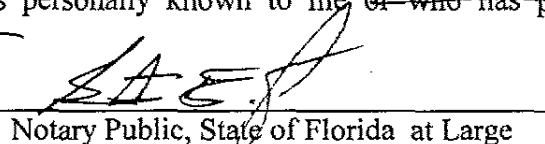
